- ◆ ENTRIES CLOSE WEDNESDAY, 1ST MARCH 2006
- ◆ ENTRY FEE OF \$10 PER ANIMAL MUST ACCOMPANY ENTRY.
- ◆ ALL ANIMALS (EXCEPTING WETHERS) MUST HAVE IAR TAGS IN EAR.
- ◆ REGISTRATION CERTIFICATE MUST ACCOMPANY ENTRY FORMS FOR ANIMALS ENTRIES (EXCEPT UNREGISTERED WETHERS).
- ◆ JOHNE'S FREE DECLARATION FORM MUST BE SIGNED AND ATTACHED TO ENTRY FORM.
- ◆ ALL ANIMALS SHOWN AT OWNERS RISK.
- ◆ AGE OF ANIMALS IS AGE ON THE DAY OF THE SHOW.
- ◆ WHITE DUST COATS TO BE WORN IN SHOW RING.
- ◆ THE SHOW COMMITTEE SHALL NOT BE RESPONSIBLE FOR THE LOSS OF, OR FOR ANY DAMAGE OR INJURY OCCASIONED TO ANY EXHIBIT OR THE PROPERTY OF ANY EXHIBITOR FROM ANY CAUSE WHATSOEVER.
- ◆ THE CHIEF STEWARDS OR INSPECTION STEWARD HAS THE ULTIMATE POWER TO CLASSIFY ALL ENTRIES FOR COLOUR AND TO INSPECT EACH EXHIBIT FOR IDENTITY AND ANY DISQUALIFYING FAULTS.
- ◆ THE CHIEF STEWARD OR INSPECTION STEWARD HAS THE POWER TO TRANSFER AN EXHIBIT TO ANOTHER CLASS IF DEEMED APPROPRIATE.
